PUBLIC NOTICE No. 05/POSFIL/2019
SIMPLIFIED SELECTION PROCESS FOR A POST-DOCTORAL GRANT (PNPD/CAPEs) IN THE
GRADUATE PROGRAM IN PHILOSOPHY (PPGFIL) OF UFSC.

PPGFIL/UFSC announces a simplified selection process for a booking-list position of 01 (one) post-doctoral grant of the program PNPD/CAPEs, beginning irrevocably on November 01st, 2019, in case the funding is confirmed by CAPEs. The grant is valid for a 12 (twelve) months term. The selected candidate will receive monthly stipends of BRL 4.100,00, paid directly by CAPEs. This notice contemplates solely the classes “A” (Brazilians, or foreigners residing in Brazil under a temporary visa with no employment bond) and “B” (foreigners residing abroad with no employment bond), according to lines “a” and “b” of item V, article 5th, of CAPEs’s Ordinance (Portaria) nº 086 of July 13th, 2013.

Candidates must submit their application by e-mail to the Secretariat of the Philosophy Graduate Program (ppgfselecao@contato.ufsc.br) until 18h00 on October 14th, 2019, identifying the field “subject” of the message as “PNPD application”. The following documents must be presented:

- 1) Written document addressed to the Program Coordination, explaining the reasons for the choice of UFSC’s PPGFIL, and indicating a supervisor.
- 2) Plan of activities to be performed during the Post-Doctoral stage, containing necessarily: a) research project; b) prevision for teaching activities; c) prevision for activities in academic outreach. The plan of activities may be written in Portuguese, English or Spanish.
- 3) Digitized copy of the PhD diploma or of a proof of defense of Doctoral Thesis or Dissertation (foreign diplomas will be accepted).
- 4) Updated CV or a link to a CV in the Lattes platform.
- 5) Specific documents for application in Class A (Brazilians, or foreigners residing in Brazil under a temporary visa with no employment bond): digitized copies of identity card and CPF; or, for foreigners, digitized copies of RNE (Registro Nacional de Estrangeiro) and of passport with visa.
- 6) Specific documents for application in Class B (foreigners residing abroad with no employment bond): digitized copies of Passport and proof of residence abroad.

The selection committee will evaluate the Plan of Activities taking into account the merits of the research proposal and the integration with the Department’s and Graduate Program’s teaching and outreach activities. Candidates that obtain a score equal or greater than 7,0 (seven) will be approved. In case of a draw, the committee will evaluate the CV. The final result, as well as the scores obtained in each stage, will be announced on PPGFIL’s internet page on October 25th, 2019. After the announcement of the result, the approved candidate must contact the secretariat and present the documentation for registry in the CAPEs system in 5 (five) business days, under penalty of disqualification.
