**PUBLIC NOTICE No. 01/POSFIL/2018**  
**SELECTION FOR THE GRADUATE PROGRAM IN PHILOSOPHY (PPGFIL) OF UFSC:**  
**MASTER AND DOCTORAL DEGREE IN PHILOSOPHY, FOR ADMISSION IN MARCH 2019.**

1. The Coordinator of the Graduate Program in Philosophy of the Federal University of Santa Catarina, in the use of his attributions, indicates that in the period from August **27 to October 11, 2018**, from 8 a.m. to 5 p.m., registration will be open for the selection process for admission to the Graduate Program in Philosophy of UFSC (PPGFIL), Master and Doctoral Degrees, for admission in the first semester of 2019.

2. THE VACANCIES. There will be 20 vacancies for admission to the Master Degree Course and 20 vacancies for the Doctoral Degree Course, in three areas of concentration: a) Epistemology and Logic, b) Ethics and Political Philosophy and c) Ontology.

3. THE SCHOLARSHIPS. The granting of scholarships complies with the regulations established by the Resolution of scholarships of the PPGFIL (<http://ppgfil.posgrad.ufsc.br/portarias>).

3.1. At each level (Master and Doctoral Degree), the granting of scholarships to candidates approved in the selection, besides observing the classification and eligibility of the candidate, will obey the following priorities related to Affirmative Action and Internationalization Policies:

- i) One of the scholarships is intended primarily to candidates with disabilities, according to Decrees 3298/1999 and 5296/2004 of the Presidency of the Republic;
- ii) One of the scholarships is intended primarily to foreign candidates who have not obtained degrees in Brazil;
- iii) One of the scholarships is intended primarily to black candidates (black or brown people);
- iv) One of the scholarships is preferably destined to candidates belonging to indigenous communities resident in the national and cross-border territories.

3.2. If the number of scholarships available is not sufficient to meet all the cases listed in item 3.1, the granting of scholarships will follow the above sequence, being more priority the granting of scholarships for candidates with disabilities, and less priority the granting of scholarships for indigenous candidates.

3.3. If there is more than one candidate approved for the same scholarship reserve, the scholarship will be granted to the best ranked candidate, and the other approved candidates opting for the same scholarship reserve will then join the general waiting list, according to the classification obtained.

4. THE REGISTRATION. To enroll in the selection process, the candidate must access the website <http://capg.sistemas.ufsc.br/inscricao/> and register, as well as submit the following documents to the Program Secretariat, as organized, within the period specified in item 1 above:

**4.1. "Volume I"**, with pages printed on both sides, containing, in the order indicated:

4.1.1) Registration form issued at the website indicated above, duly completed;

4.1.2) Photocopies of the following documents: (i) identity card, (ii) birth or marriage certificate, (iii) diploma of the undergraduate course (certified copy) or declaration of completion of course, (iv) Undergraduate Degree course transcripts, (v) diploma of the Master Degree course (if any), (vi) Master Degree course transcripts (if any), (vii) *curriculum lattes or curriculum vitae* with proof of only the last

three years. In relation to proof of publication, comply with the following guidelines: a) books and chapters: copy of the cover of the work, catalog record with ISBN, summary and first page of the chapter (when applicable); b) articles published in scientific journals: copy of the first page containing the name of the journal, DOI / ISSN or other identification data (when this information is not available on the first page of the article, also attach a copy of another supporting document);

4.1.3) written document addressed to the Program Coordination, explaining the reasons why the candidate wants to take the course and a statement as to whether or not the candidate needs a scholarship to take the intended course;

4.1.4) sheet with the title of the research project and the name of the intended advisor;

4.1.5) only for candidates who compete for the preferred scholarships described in item 3 above:

4.1.5.1) Candidates with disabilities:

i) **Self-declaration of disabled person**, according to the model (Annex I), printed and signed by the candidate, certifying that he / she complies with the conditions required by the scholarship reserve of the PPGFIL Affirmative Action Policy.

ii) **Applicants must provide the following supporting documents:**

I - Medical report, carried out no more than twelve months prior to enrollment in this selection process, which must be signed by a doctor specialized in the area of the candidate's disability, containing, in the clinical description, the degree or level of disability with express reference to the corresponding International Classification of Diseases (ICD) code. It must also contain the legible name, stamp, signature and CRM of the doctor who provided the certificate.

II - For candidates with Hearing Impairment (Deafness), in addition to the medical report, they must present an audiometry exam, carried out in the twelve months prior to enrollment in this selective process, containing the legible name, stamp, signature and CRM of the professional who performed the exam.

III - For candidates with Visual Impairment, in addition to the medical report, they must present an ophthalmological examination in which the visual acuity is recorded, carried out at the most in the twelve months prior to enrollment in this selection process, containing the legible name, stamp, signature and CRM of the professional who performed the exam.

The documentation of the candidates registered for the vacancies as persons with disabilities will be analyzed by the Commission for the Validation of the Self-Declaration of Persons with Disabilities designated by the Secretariat for Affirmative Actions and Diversities (SAAD).

If necessary, the Commission may ask the candidates to provide additional documentation and / or attend a face-to-face interview.

4.1.5.2) Foreign applicants not qualified in Brazil:

i) **Self-declaration of foreigner not qualified in Brazil**, according to the model (Annex II), printed and signed by the candidate, certifying that he / she complies with the conditions required by the scholarship reserve of the PPGFIL Internationalization Policy.

The selection commission of the desired degree (Master or Doctoral Degree) will validate the self-declaration on the basis of the documentation provided and may, if necessary, ask applicants to provide additional documentation.

4.1.5.3) Black candidates (black or brown people):

i) **Self-declaration of black person (black or brown)**, according to the model (Annex III), printed and signed by the candidate, certifying that he / she complies with the conditions required by the scholarship reserve of the PPGFIL Affirmative Action Policy.

The validation of the Black or Brown person self-declaration will be made by the Commission for the Validation of Black and Brown Person Self-Declaration, specifically constituted for this purpose, appointed by the Secretariat for Affirmative Actions and Diversities (SAAD), with the following criteria: the self-declared black or brown person must possess phenotypic aspects that characterize he / she as belonging to the black racial group.

4.1.5.4) Indigenous candidates:

i) **Self-declaration of belonging to indigenous people resident in national and in cross-border territories**, according to the attached model (Annex IV), printed and signed by the candidate, with information on ethnicity, village and municipality / village state, certifying that he / she meets the

conditions required for the scholarship reserve of the PPGFIL Affirmative Action Policy;

ii) **Document attesting to belonging to indigenous people residing in the national or cross-border territories** issued by 1 (one) recognized indigenous authority or by the National Indian Foundation (Fundação Nacional do Índio - FUNAI).

The validation of the Indigenous self-declaration will be made by the Commission for the Validation of Indigenous self-declaration, specifically constituted for this purpose, appointed by the Secretariat for Affirmative Actions and Diversities (SAAD).

*During the period from 19 to 26 October, on a date, time and place to be published on the PPGFIL website, the self-declared black (black or brown) candidates and indigenous candidates must present themselves to the respective Commission appointed by the Secretariat for Affirmative Actions and Diversities (SAAD) to verify self-declaration. Candidates with disabilities may be asked to present themselves, during this period, if there is a need for completing documentation or evaluation.*

*Candidates who do not prove the requirements regarding the modality in which they have been classified may still have their registration approved, although they are no longer eligible for the indicated priority grant. Candidates who provide false information regarding the requirements established by the UFSC Normative Resolution will be subject to penalties for crimes provided by law.*

**4.2. "Volume II",** with pages printed on both sides, containing a copy of the research project, ***without identification of the proposer, being automatically disqualified whoever fails to obey the rule of anonymity.***

In addition to the printed version, the candidate should submit copy of the project in PDF file version (**equally anonymous, under penalty of declassification from the process**) to the email address <selecaoppffilufsc@gmail.com>, identifying in the "subject" the full name of the candidate, and *in the email text*: i) the course degree to which the candidate competes, ii) the name of the advisor, and iii) the title of the project, **until midnight on October 11**. The PDF file should be saved with the title of the project.

Registrations will be accepted by mail, via SEDEX, as long as the post is dated until **October 11, 2018** and the Program Secretariat receives it until **October 19, 2018**. The candidate must send a digital copy of the proof of post to the email: <selecaoppffilufsc@gmail.com>. The material should be sent to: Universidade Federal de Santa Catarina / Programa de Pós-Graduação em Filosofia / Campus Universitário / Trindade / CP 476 / CEP 88040-900 / Florianópolis / SC / Brasil. Possible problems with the delivery of correspondence, such as loss or strike at the Post Office, are entirely the responsibility of the candidate. **By 6 p.m. on October 29, the list of approved registrations will be announced on the website and in the PPGFIL Secretariat.**

***Failure to submit all the documents listed above, including the PDF project, or to send an illegible document, will result in non-approval of the application.***

5. PROFICIENCY IN LANGUAGES. According to Ordinance 002/POSFIL/2017, the candidates approved in the selection process must present proof of proficiency in foreign languages, at the time of enrollment. In the case of the Master's Degree, the foreign language to be proved is obligatorily the English language; in the case of Doctoral Degree, the English language and a foreign language, among the following, must be proven: French, German, Spanish and Italian.

Proof of proficiency provided by DLLE of UFSC or by a Brazilian higher education institution with a foreign language course recognized by the MEC is accepted. In addition to these, applicants may submit the following proofs, within the validity period established by the certificate, up to a maximum of five years:

(a) English language: (i) TOEFL IBT - Internet Based Test (minimum score 65), (ii) TOEFL CBT - Computer Based Test (minimum score 183), (iii) TOEFL ITP - Institutional Testing Program (minimum score 513), (iv) International English Language Test - IETLS (minimum score 5.5), (v) Test of English for International Communication - TOEIC (minimum of 605 points), (vi) Cambridge FCE (First Certificate in English or superior) (scores A, B or C);

(b) French language: DELF B1 or higher certificate of the Alliance Française;

(c) German language: Zertifikat Deutsch B1 or higher certificate of the Goethe Institute;

(d) Spanish language: DELE B1 or higher certificate of the Instituto Cervantes;

(e) Italian language: CILS UM-B1 or higher certificate of the Instituto Italiano de Cultura.

Students entering the Doctoral Degree with prior approval in English in a graduate program recognized

by CAPES may be exempted from the proficiency of this one, upon presentation of the academic transcripts.

Native students from countries whose official language is among those required in PPGFIL (English, Spanish, French, German, and Italian) will be exempt from proof of proficiency in their native foreign language.

Foreign students, in addition to the required proficiency at the corresponding graduate degree, must also prove proficiency in Portuguese, demonstrating it by submitting one of the certificates mentioned below, within the validity period established by the certificate, up to a maximum of five years:: a) CELPE-Bras (intermediate or superior); b) proof of proficiency provided by the DLLE of UFSC or by a Brazilian higher education institution with a foreign language course recognized by the MEC.

6. **PROOF OF COURSE CONCLUSION.** The successful candidates must submit, at the time of enrollment, the Diploma of Completion of the Undergraduate Course or a Declaration that certifies the conclusion of the course. Failure to submit documents at the time of enrollment will result in the applicant not being admitted to the Program.

7. **THE ADVISOR.** It is compulsory for the candidate to indicate a possible advisor teacher among those who make up the teaching staff of the program. Information about the faculty and their work can be accessed at the following address: <http://ppgfil.posgrad.ufsc.br/>. If the indicated advisor teacher is prevented from assuming the orientation, the coordinator of the program will appoint another one, for the purposes of the selection process.

8. **THE ADMISSION.** The admission of a candidate as a regular student of the Master or Doctoral Degree Course will be conditioned to the approval in the selection process, carried out under the responsibility of the Commission designated for that purpose by the Program Collegiate. The selection exam will consist of the following tests: Analysis of the Research Project, Proof of Philosophical Knowledge and Argumentation of the Research Project, on the dates specified below. All tests will have eliminatory character.

9. **ANALYSIS OF THE RESEARCH PROJECT.** The project should include: title, area, advisor, abstract, keywords, main objective, secondary objectives, justification, brief development of the topic to be studied and references. In the case of the Master Degree, the total number of pages of the project should not exceed 15, and in the case of the Doctoral Degree, it should not exceed 25, being presented in Times New Roman font, size 12, space between lines 1.5, margins of 2.0 cm, in A4 sheet. Projects are accepted in Portuguese, Spanish and English. The projects will be referred blindly for evaluation by the Selection Commission, in terms of their philosophical merit, feasibility, adequacy to PPGFIL proposals and lines of action, and adequacy and relevance of the suggested bibliography. The projects will be classified by the Selection Commission as "accepted" or "eliminated", without issuing a note. The list of candidates approved in the project will be disclosed in the PPGFIL Secretariat and in the Program webpage, **on November 5, 2018, until 6:00 p.m.**

10. **THE PROOF OF PHILOSOPHICAL KNOWLEDGE.** Proof of philosophical knowledge will be held on **November 19, 2018**, at the CFH Auditorium, and the candidate must present himself / herself to the selection commission at this venue **until 8:00 a.m.**, when the doors will be closed. The candidate who arrives at the place of the test after the closing of the doors will not be able to perform it, regardless of the reasons given, being automatically disqualified from the selection process. The test will be carried out from 9 a.m. to 1 p.m., and it should be answered with a black ink pen. The test will be composed of three questions, one on each of the following texts: **for the selection to the Master Degree:** a) Ontology: Aristotle, Poetics; b) Ethics and Political Philosophy: Peter Singer, Practical Ethics (Chapters 1, 2 and 3); c) Epistemology and Logic: T. S. Kuhn, *The Structure of Scientific Revolutions*. Chapters: "The Route to Normal Science", "The Nature of Normal Science", "Normal Science as Puzzle-Solving", "The Priority of Paradigms"; **for the selection to the Doctoral Degree:** a) Ontology: I. Kant, First Introduction to the Critique of Judgment; b) John Rawls, Political Liberalism ("Fundamental Ideals"); c) Epistemology and Logic: I. Kant, *Critique of Pure Reason*, "Introduction". The candidate will choose among the three questions one that will be worth 60% of the score; the other two questions will be worth 20% each. The test will be carried out without consultation of texts or any other annotations, and the use of electronic equipment, except in cases supported by law, will not be allowed. Responses are accepted in Portuguese, Spanish and English. The test will last four hours. After a blind evaluation by the members of the Selection Commission, the candidate who will obtain a score of 6 or higher in a decimal scale, a result from the arithmetic mean of each evaluator's grades, will be considered approved. The announcement of

the nome of the approved ones in the test of philosophical knowledge will occur on **November 21, 2018, until 6:00 p.m.**, in the PPGFIL Secretariat and on the Program website.

11. THE PROOF OF ARGUMENTATION OF THE RESEARCH PROJECT. The candidate's argumentation will be held on **November 22, 23 and 24, 2018**, at a place that will be announced at the Secretariat and on the PPGFIL website. The candidate will have up to five minutes to present his / her research project; and only after which, the examining board will debate for a maximum of fifteen minutes. The proof of argumentation will evaluate the adequacy of the candidate's academic background, given his / her *Curriculum Vitae or Curriculum Vitae*, regarding the research project presented, the mastery of the proposed topic, the feasibility of the proposed objectives, the presentation of the project, and the defense of the philosophical relevance of the proposed theme and bibliography. The candidate who will obtain a score of 7 or higher, in decimal scale, will be considered approved.

12. THE APPEALS. The right to appeal is guaranteed, which must be addressed to the PPGFIL Coordination within a period of up to 24 hours after the disclosure of the results of each stage.

13. THE APPROVAL IN THE SELECTION: these are necessary conditions for approval in the selection: 1) approval at each stage of the selection and 2) the achievement of a final grade equal to or greater than seven, calculated by the arithmetic average of the grade of the proof of argumentation and the proof of philosophical knowledge.

14. The list of candidates approved in the Proof of Argumentation, and the final list of those approved in the selection process, after approval by the Program Collegiate, will be announced **until 6:00 p.m. on November 27, 2018**, in the PPGFIL Secretariat and on the Program website.

15. PPGFIL has the right not to fill the vacancies indicated above.

16. PPGFIL has the right to redistribute vacancies between degrees, in case of not filling the total number of places provided.

17. The enrollment and the beginning of the course will occur in 2019, according to the academic calendar.

18. The non-approved candidate will have until the 30th of March 2019 to withdraw the registration material in the secretariat. After this deadline, the material will be destroyed.

19. The Selection Commission for the Master Degree will consist of teachers Dr. Milene Consenso Tonetto and Dr. Janyne Sattler (representatives of the area of Ethics and Political Philosophy), of teachers Dr. Alexandre Meyer Luz and Gustavo Caponi (representatives of the area of Epistemology and Logic) and of teachers Dr. Carolina de Souza Noto and Dr. Ulisses Razzante Vaccari (representatives of the area of Ontology), under the chairmanship of the first.

20. The Selection Commission for the Doctoral Degree will consist of teachers Dr. Alberto Oscar Cupani and Dr. Ivan Ferreira da Cunha (representatives of the area of Epistemology and Logic), of teachers Dr. Darlei Dall'Agnol and Dr. Joel Thiago Klein (representatives of the area of Ethics and Political Philosophy), and of teachers Dr. Celso R. Braida and Dr. Marcos Müller (representatives of the area of Ontology), under the chairmanship of the first.

21. The candidate who needs any type of special condition to carry out the stages of this Selection Process, must request it at the time of registration, attaching the application request to the enrollment form, explaining the type of differentiated care and medical report that justifies it.

22. The missing cases will be solved by the Delegated Collegiate of the Program.
